How much time will it take to get my visa?

Be sure to allow extra time for your visa application. Immediately after you've been accepted to and enrolled in the university of your choice, you can already start your application for the Canadian Study permit. You should apply at least 3 months before your university degree program starts. After you've applied, you can expect that you'll wait at least 8-9 weeks for the decision.






CANADIAN STUDENT VISA APPLICATION

Canada offers high quality, low cost education, with tuition rates lower than other first world and developed countries. The academic environment in Canadian Universities and colleges is excellent, with a focus not just on classroom lectures, but also on the acquirement of practical skills in respected fields which enable students to know how to use their knowledge in real life. Canada welcomes international students each year. If you intend to study at a Canadian educational institution in undergrad or post-graduation or Masters/PhD program, most foreign nationals must apply for a study permit. A Study Permit is a document issued by Immigration, Refugees and Citizenship Canada (IRCC) that allows a foreign national to study in Canada at an approved institute for the duration of the specified program.

TO BE ELIGIBLE TO STUDY IN CANADA



Obtain a Letter of Acceptance from a designated learning Institution in order to submit an application for a study permit



Prove that he or she has sufficient financial support to cover the first year of tuition, as well as living expenses and return transportation to his or her country of origin



Must be a law-abiding citizen with no criminal record and poses no risk to Canadian security. You may have to provide a Police Certificate from country of residence



You must be in good health and IRCC may request an applicant to complete a medical examination, if necessary



Applicant must satisfy an immigration officer that he/she will leave Canada at the end of his/her authorized stay
