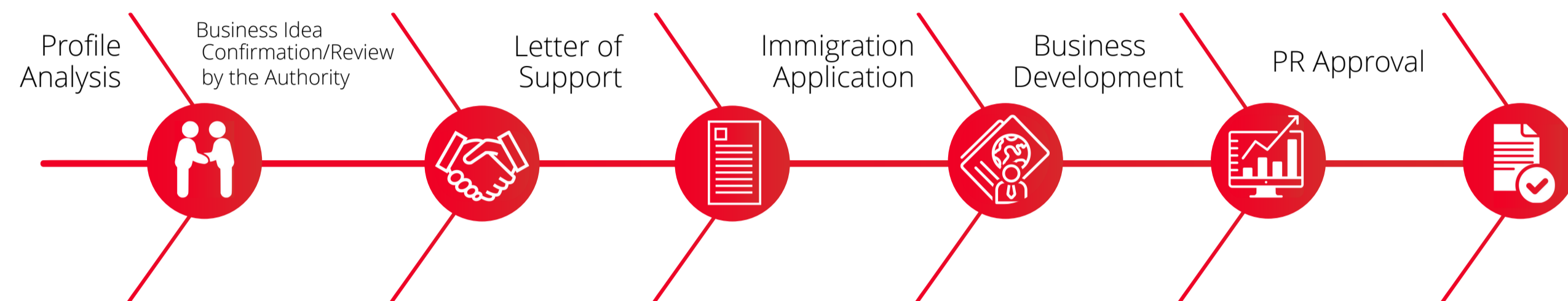

The main applicant must provide English or French test results of at least CLB5 (IELTS 5 except for Reading Factor IELTS 4)



### LETTER OF SUPPORT

Essential document to submit the PR and/or WP application is the letter of support that is issued to the applicant as part of a Commitment Certificate directly transmitted to IRCC by the Designated Organization.



### INNOVATION

The SUV applicant must intend to develop an innovative and scalable business from within Canada.

Direct permanent residency status is granted to successful SUV applicant, spouse and dependent children under the age of 22 years old.



#### QUICK ACCESS

With a letter of support from a designated organization, SUV applicant can apply for work permit to quickly develop their business from within Canada

a dedicated team provides comprehensive support to help the SUV applicants navigate the business development from within Canada.





# A SHORT HISTORY

The Start-up Visa Program (also named "SUV") was launched by the federal government in 2013 as a pilot program. In July 2017, the Canada Immigration Department announced its intention to make the program permanent, which was confirmed by regulations in April 2018.

Since that date, the government has increased its intake targets recognizing the value of the SUV program.



The Canadian government has announced its intention to increase its immigration targets in almost all categories. The start-up visa program has seen its target increased by 42.8% to about 1000 to 1250 applicants per year.
